Smt. Lokasundari Raman, wife of Nobel Laureate Sir. C.V Raman was the founder President of KSCCW. The plight of children marginalised and neglected due to poverty touched her deeply inspiring her to start a play school and library in her home at Malleshwaram, Bengaluru. That was the beginning of Karnataka State Council for Child Welfare.

With her great humanitarian qualities she was able to help a large number of women and children in distress and laid the foundation for the various welfare and development programmes that KSCCW continues to be engaged in.

Smt. Lokasundari Raman served as our President from 1955 to 1977 and thereafter as our Life Patron until her demise in May 1980.

Lady Raman continues to remain the beacon of light for all of us who have joined KSCCW and volunteer our time and energy for the causes she so dearly espoused.

From the President's Desk

It is indeed my pleasure to present you with the Annual Report for the year 2022-2023, which provides a detailed account of our work and highlights the spirit of service of our members, the commitment of our staff team and above all, the support of our donors and well wishers who have walked the path with us. As Mahatma Gandhi said, "The best way to find yourself is to lose yourself in the service of others.". Post pandemic, we have seen a steady rise in momentum this year.

One of the focus areas of KSCCW has always been children and women; the most vulnerable sections of society. We aim to provide them with the educational support, health care, and vocational skills needed to enable them to become self-sufficient, responsible citizens of our future society. For example, Arogya that provides free health care services for under privileged children and women. Our very successful Balika Shikshana Samruddhi Scheme continues to support girl children studying in high school for nine districts of Karnataka. The Physiotherapy Centre helmed by Mr Dinesh Kumar (Physiotherapist) conducts regular sessions and 13 children have benefited.

For children who cannot afford access to expensive libraries, we have created a comfortable, secure space - Mrs. Meenakshi Sivaramkrishnan Reading Room. Currently over 40 children school going children utilize this facility as a reading room and home work center.

Altair Engineering India Pvt Ltd continues to support our 3 creche centers. The day care center is a boon to all the low income working mothers. Mid- day meals are provided for the children. Our Bala Sevika Training Institute has trained 30 young women this year, with support from the Rotary Club of R T Nagar.

Donations from philanthropists help us to continue educational support to over 300 school children.

In the latest development, in compliance with the new Adoption Regulations 2022, all adoption orders are now being issued by the District Magistrates. Therefore, the Karnataka State Council has stopped receiving adoption petitions under the Juvenile Justice Act, for scrutiny from the courts from September 2022.

We would like to thank everyone who has been a part of this journey and helped us to make our programmes a success.

We have many miles to go, and our hope is to enhance the lives of many more people in society through timely help and support.

Painting Competition 2022

The Annual painting competition was held on 3rd Sept 2022 at five zones in Bengaluru – Jayamahal, R.T. Nagar, Krishnanagar, Indiranagar, Chamrajpet, around 1900 children, including children with disabilities participated in the competition. The paintings were evaluated at the KSCCW by three judges from the field of art Dr. Indu Parathasarthy Mrs. Mangala Gowda and Mrs. Meera Hegde. Our sincere appreciation and thanks to them.

Children from Kodagu District Council also participated. Prizes for each group and zone were given apart from the prizes for District Council participants. Prize distribution for the winners was held on 17th December 2022. The selected entries were forwarded for National level judging to ICCW, New Delhi and the winners were given cash awards accordingly.

The winners at the National level, whose family income is less than Rs. 5000/- per month are also eligible to receive scholarship from ICCW till the child completes 12th std education.





Adoption Scrutiny

KSCCW was nominated by the Registrar General of the High Court of Karnataka in the year 1986 as the sole scrutiny agency for scrutinizing adoption petitions filed in the state of Karnataka.

Children in need of care and protection, who are eligible for adoption, are placed in adoption by Specialized Adoption Agencies through a centralized online portal called Child Adoption Resource Information and Guidance System (CARINGS).

There are 34 Specialized Adoption Agencies in Karnataka that are recognised by the state to place children in adoption. KSCCW receives adoption petitions from District & Session Courts and Family Courts of Districts and the City Civil Court in Bengaluru. KSCCW scrutinizes the documentation in the dossier that accompanies the case petition to ascertain that the dossier is complete and correct in all respects. The scrutiny also includes ensuring that the process followed is as per the adoption regulations notified by the Central Adoption and Resource Authority (CARA). A scrutiny team, comprising a scrutiny officer and a member of KSCCW, meet the prospective adoptive family to assess if the prospective adoptive parents have been able build a rapport with the child during the pre-adoption foster care stage and identify any areas of concern with regards to suitability of the parents for the specific child placed with them. The objective of the scrutiny process is to assess if the placement is in the best interest of the child. A report of our observations is submitted to the concerned court. As a part of the process, KSCCW ensures that information regarding disclosure of the fact of adoption, legal rights of the adoptive child is given to the Prospective Adoptive Parents.

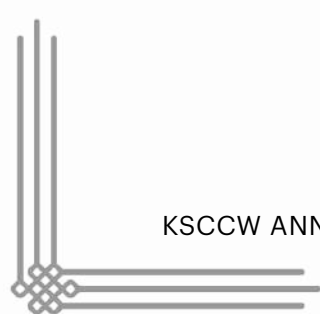
In the year 2022-23, KSCCW scrutinized a total of 52 petitions⁴⁴ of those were in-country adoptions and 8 were inter-country adoptions filed under the Juvenile Justice (Care and Protection of Children) Act 2015. The Table below gives the list of cases scrutinized with a break-up of whether the placement was of a normal child, a child above 5 years (older child), siblings or a child with special needs.

There was one petition of an older child adoption and eight petitions for children with special needs. Among the children placed in in-country adoption, 43 children were normal and below the age of 5 years, and one older child. Children placed in inter-country adoption were placed with families living in Canada, USA and Italy. All the 8 children placed in inter-country adoption were children with special needs.

In compliance with the provisions of the Juvenile Justice (Care and Protection of Children) Amendment Act 2021, notified on 7th August 2021, the corresponding Juvenile Justice (Care and Protection of Children) Model Amendment Rules, 2022 notified on 1st September 2022 and the new Adoption Regulations 2022, all adoption orders are now being issued by the District Magistrates from 23rd September 2022. The scrutiny process is being conducted by the respective District Child Protection Units. Therefore, the KSCCW has stopped receiving adoption petitions under the Juvenile Justice Act, for scrutiny from the courts from September 2022.



AROGYA

Health Care Services for Women & Children.

KSCCW's AROGYA – health care centre was started in the year 2018 to provide medical facilities for women and children from economically weaker sections . Dr. Neeta Dhiren, General Physician from Veritas Diagnostics, Jayamahar visits the centre located at our office premises for 2 hours in the evenings from Monday to Friday.

The residents of Working Women's Hostel, Balasevika trainees, children from Sharanya Children's Home and Crèches utilize this medical consultation facility regularly.

Balika Shikshana Samruddhi Scheme

Balika Shikshana Samruddhi Scheme is an Educational Sponsorship Scheme for girl children studying in high school i.e. 8th, 9th and 10th standards at Government and Corporation schools in Karnataka. This scheme was extended to reach children from the 5 districts - Belagavi, Davangere, Dakshina Kannada, Kodagu and Shivamogga, through our District Councils. Nine children from each District, totally 45 girl children benefitted from this scheme in the year 2022 - 23.

Bal Vidya School Development Project

Bal Vidya School Development Project commenced in the year 2008. With continuous support from TTK Prestige Ltd the project is being successfully implemented for the past 15 years. The project aims to improve the growth and health condition of the children from rural Bengaluru studying in government schools. The children come from lower economic backgrounds and most of them come to school without having their breakfast.

The nutrition supplements which are being provided to these children include Beaten Rice mixed with jaggery, sprouted moong gram, banana / watermelon, chikki and nutrition powder made with sprouted and dried millets, wheat and pulses. Para Teachers are engaged by the project in each school to distribute these nutrition supplements every day which are relished by the children. The school teachers, students and parents are very grateful for the much needed nutritional supplements in the morning.

The height and weight of the children are recorded and monitored periodically. This year the children participated in the National Painting competition conducted by KSCCW during the month of September 2022. All the children participated with enthusiasm. Participation certificates and prizes were distributed.

A summer camp was conducted during the last week of March 2023 after the annual examination. Children were provided with different opportunities to explore and display their talents and skills. Prizes were distributed to the best performers.



Bal Roshni

Bal Roshni is an early identification, intervention and support programme for children with special needs. It provides physical, medical and educational rehabilitation for children with disabilities from disadvantaged sections of society. Currently 135 special children receive medical and educational assistance. Corrective surgeries, providing special shoes, callipers, crutches and other assistive devices such as hearing aids, spectacles, and wheel chairs are a regular part of the programme. Financial assistance to continue formal education is a priority of this project.

Highlights for the year 2022-23

- ❖ 80 children were given educational sponsorship.
- ❖ 21 children were given financial assistance for surgeries and medicines
- ❖ 20 children were provided aids and appliances
- ❖ 10 children were given financial assistance for club foot treatment
- ❖ 4 children were sponsored under '**Smt. Kavery Nadamangalam Vision Endowment Fund**' which provides support for early identification and treatment of visually impaired children.

Bal Roshni get together programme was held on 10th December 2022 at KSCCW. Around 52 beneficiaries of the project attended the event. Cultural performances were organized by the students of Balasevika Training Programme. The children sang, danced, performed skits, and showcased their talent enthusiastically. It was overwhelming to see the children perform. Bal Roshni get together was an eventful day and the children enjoyed it thoroughly. Refreshments and gifts were given to all the participants.



Physiotherapy Unit

Many of our beneficiaries need physiotherapy before and after they undergo a surgery. They find it difficult to commute to the physiotherapy centers located at different places. The cost of the physiotherapy sessions are also high and they cannot afford it. KSCCW started a physiotherapy centre for differently abled children in 2014. Many children have benefitted from this centre.

We thank Mr. Dinesh Kumar Physiotherapist, for his sincere and dedicated work for these children.



Balasevika Training Programme

The 58th batch of Balasevika Training programme commenced on 10th June 2022 with an enrolment of 34 candidates for the 10-month training course. Candidates from the economically weaker section of society were given preference. During the period of training, students obtained theoretical and practical knowledge in Child Development, Preschool-Education, Health and Nutrition, Social Work, working with children with disabilities, Computer basics, Spoken English, Craft, Tailoring, Music and Drama. The training prepared the students to serve the community as pre-school educators, social field workers or supportive teachers in special schools. The 58th batch of Balasevika Training programme for the year 2022- 2023 was sponsored by Rotary RT Nagar Trust, RT Nagar, Bengaluru

The training includes the following components:

- ▶ Child Development & Preschool Education, Social Work, Health & Nutrition, Special education – early identification of childhood disabilities, Vocational Training in sewing and tailoring, embroidery, preparation of teaching aids, spoken English, life skill education & basic computer usage.
- ▶ This enables the trainees to serve as Balasevikas at -
 - ▶ Crèches/ Balwadis
 - ▶ Child & Community development programmes
 - ▶ Childcare institutions for Normal & Special needs children.



Highlights of the programme:

- ▶ Inauguration of the BSTI 58th batch training programme was held on 15th June 2022.
- ▶ As a part of the curriculum, trainees were placed for practical classes at different pre-schools, special schools and social work organisations.
- ▶ Workshops and awareness programmes on various topics were conducted as a part of the training programme.
- ▶ Nutrition week was celebrated during Sept 2022. Practical sessions on - cooking without fire, low cost baking, followed by workshop on 'Balanced Diet' by Dr. Indiramma VHD, Home Science College, Bengaluru was conducted.
- ▶ Block work for the trainees was conducted from 17/1/2023 to 4/02/2023 at Sriramanahalli, Bengaluru rural.
- ▶ Annual cultural competitions for trainees were held during 3rd week of March 2023.
- ▶ Final exams for the 58th batch was held during first week of March 2023.
- ▶ Valedictory function was held on 31st March 2023, The chief guest of the function was Mr. T.N. Muniswami – Special officer (Retd), India Population Control Project, Govt. of India. The programme was followed by distribution of prizes for winners in the cultural competition and distribution of marks card and course completion certificate.
- ▶ Campus interviews for the 58th batch were held from 27th March to 30th March 2023. 17 trainees have been placed in different organizations and the others have been referred to various organizations for placements.





Creche Programme

Early Childhood Care & Education

Altair Engineering India Private Limited, Bengaluru, has been supporting the Creche programme since December 2018. KSCCW has been successfully managing 3 creche units, two crèches at Jayamahala and one crèche at R T Nagar. The project takes care of preschool education, nutrition and health of children enrolled in the creches. It empowers working mothers by helping them to continue with their employment and thus improving the standard of living of the families. The project also helps older children in the family to pursue education instead of taking care of younger siblings. Most of their mothers work as domestic workers, labourers, construction workers and some are ailing mothers unable to take care of their children. At present 90 children in the age group of 2-6 years are the beneficiaries of the programme.

Mid day meals are provided for the children to meet their nutritional needs. Eggs and seasonal fruits are also included in their meals regularly. Special meals are provided on occasions, like children's birthdays and festivals.

Health check ups were conducted regularly by Dr. Srilakshmi and Dr. Neetha Dhiren, from Veritas Diagnostic Centre, Jayamahala, Bengaluru. Height and weight are recorded to monitor the growth of the children. Importance is given to personal hygiene. De-worming tablets and Vitamin A drops are regularly given to the children by the health workers from nearby BBMP Primary Health Centre.

Mother's meetings are conducted periodically for the mothers to gain knowledge on various aspects like - role of parents in Child Development during 2-6 years, awareness to mothers on child rights, importance of nutrition, safe drinking water, health and care etc.

National and religious festivals are celebrated at our crèche centres to create awareness about the special days and to learn about our culture and significance. Children's Day was celebrated on November 18th 2022 where children showcased their talents and prizes were distributed. Sports day was conducted in March 2023.

Workshop on Early Childhood Care and Education was conducted for the Creche teachers as part of their **Capacity Building Programme** on 7th and 19th September 2022 by Dr. Meena Jain who is a noted developmental psychologist and a rehabilitation expert.

Training was given to the creche staff on **assessment of children for early intervention** on 23rd and 30th November 2022 by Mr. Reuben Daniel Chandrashekhar and Mrs. Merlyn from 'PACT India'. The training covered - Screening and Reporting of 12 conditions frequently identified in children which can be helped with early intervention.

Nutrition and Child Development sessions were conducted by Mrs Geetha and Mrs. Pallavi, instructors at Balasevika Training programme.



Education Sponsorship Programmes

Education Sponsorship I

The programme was started in 1992 with a small group of students and has increased to 73. The students assisted for education are from 6th to 10th standard. The following table lists the number of beneficiaries in each class.

Annual financial assistance was given to the students. Letters from students and progress reports were sent to their respective donors. After the students complete their 10th standard the sponsorship assistance is provided to buy their study materials and books. This year 20 students who are in Pre University College and Degree college were given financial support to buy books.

Education Sponsorship II

25 children studying from class 2nd to 5th standard are supported with financial assistance for their education.

Education Sponsorship III

This programme was started 28 years ago and continues to focus on the education of less privileged children. At present, 53 children are sponsored under the programme. These children who live with their families are being offered financial support for education. The beneficiaries study in primary, middle, high schools and college.

Annual get-together programme was held on 7th January 2023 at KSCCW. All the beneficiaries of this programme attended the same. Cultural performances were given by the children. All the children participated enthusiastically. Group games were organized for the beneficiaries and their parents. The programme was an eventful day for the children and they enjoyed thoroughly. Refreshments and gifts were given to all the participants.





Education Sponsorship IV

TaeguTec India Private Limited, Bengaluru

Under TaeguTecIndia Pvt. Ltd -“SHIKSHAK SCHOLARSHIP SCHEME”, 9 students are supported for 2 years Pre-University Course.

ICCW Sponsorship

12 children are given educational support under this sponsorship scheme.

Altair Sponsorship Programme

13 students have received educational sponsorship under Altair sponsorship programme.

Smt. Meera Nayak Endowment Fund

The support for Professional Course was started in the year 2009. Many deserving and meritorious students pursuing their professional courses are supported under this fund from Mrs. MeeraNayak, our Patron. At present, 17 students get financial assistance. Seven students are pursuing the Medical stream and 10 students are pursuing the Engineering stream.

One student has completed B Tech from IIT Varanasi and another student has completed MBBS successfully. Many students who have completed their Engineering got jobs in various IT companies. Students who have completed their MBBS are doing their internships and compulsory rural service.

Smt. Meenakshi Sivaramakrishnan Reading Room

Since April 2019, Smt. Meenakshi Sivaramakrishnan, our past President, has continued to support the Reading Room for children. Around 40 children from the vicinity come regularly to the centre to read general knowledge and story books from 4 p.m to 6 p.m as well as do their homework. Two teachers and two volunteers help the children with their homework and academics.

On Saturdays the children come early and are engaged in different group activities, games and dance. All National and religious festivals were celebrated. An annual summer camp and get together programmes were also conducted for these children.



Sharanya Children's Home


Sharanya Children's Home is a Child Care Institute registered under the Juvenile Justice (Care and Protection of Children) Act. It was started in the year 1991 at R T Nagar, Bengaluru as a Destitute Cottage under the Department of Women and Child Development, Government of Karnataka.

Sharanya Children's Home houses girl children between the age group of 12 and 18 years. At present the number of children is 15 and the capacity of the Child Care Institute is 25. The children are from economically backward and single parent families. They are provided with safe accommodation, schooling, nutritious food, medical assistance and recreation.

Tutors are engaged to help the children in filling the gaps in academic learning. Other life skills like Karate, Yoga, Tailoring, Spoken English, and basic computer knowledge are being taught to the children. Regular counseling service is provided for children.

Children have passed Karate Yellow and Orange Belt exams and have also participated and won prizes in the online Karate tournaments. Summer camp was





conducted which included Computer training, Tailoring, Soft skills, Life Skills, Arts and Craft.

Regular medical check ups were carried out by Dr. Srilakshmi and Dr. Neeta Dhiren from VERITAS Diagnostics, Bengaluru. Regular Dental check up is done by the Doctors from Rajiv Gandhi Institute of Dental Sciences and Hospital, Bengaluru.

During the academic year 2022 – 23, five children appeared for SSLC exam and passed their exams. Mallamma, scored 89% in the SSLC exams and was the topper in school. Three of girls were joined Pre-University college and one girl was admitted to KSCCW's Bal Sevika training programme. Children have participated and have won prizes and awards in various competitions.

Assessment of children was conducted by an organization called Prakhyat Abhinandan Charitable Trust (PACT India) to screen the children for special needs. Training was given to the staff for the same. Sharanya Children's Home was the winner at PACT India - COHORT 1 Bronze Category, given to the child care institutes screened to identify, acknowledge, encourage inclusive practices for the children in need of care and protection.

Tailoring Unit

KSCCW's Tailoring Unit was set up in the year 2006 to facilitate the economically disadvantaged young girls and women from the nearby community. This project focuses to create sustainable livelihood for women & young girls and also to build confidence among them. This self-employment training program has made a difference in the lives of many women & their families.

This year the programme was funded by Indian Council for Child Welfare, New Delhi.



- * 54 students have benefitted from this Vocational training unit for the period 1/ 4/ 2022 – 31/ 3/ 2023.
- * The following numbers of students were enrolled for the morning and evening batches:

- * All the students were first trained in basic hand stitches like tacking, hemming, fixing of buttons, hooks, button holes, hook eyes, etc.
- * Then, they begin with measurements of each garment, make notes and paper cutting and learn to sew different types of garments.
- * Exams are conducted after every 4 months and course completion certificate is given to the students who have passed the examination.
- * The best student from each batch was awarded a sewing machine with which they can earn their livelihood.





Lokasundari Raman Working Women's Hostel

The Lokasundari Raman Working Women's Hostel was set up for marginalised and socially disadvantaged women from rural and distant areas who migrate to Bengaluru in search of employment. The Working Women's Hostel, located behind the office premises, has nine rooms and two dormitories which can accommodate 30 working women. Quality food at reasonable rate is provided. Admission to the hostel is subject to appropriate employment letter and salary certificate etc. Before joining every applicant is informed of the rules and regulations governing the hostel which they are expected to adhere to during their stay in the hostel. Subsidized accommodation in the hostel is also provided to Balasevika trainees and a few college students.

The warden, assisted by ancillary staff supervises the day-to-day functioning of the hostel under the direction of the member-in-charge. All religious festivals are celebrated in the Hostel with fervor and gaiety and special meals are prepared on these occasions. Overall, the hostel functions as a close-knit unit. It is made to be a home away from home for the women staying here. At present 15 working women and BST students reside at the hostel.

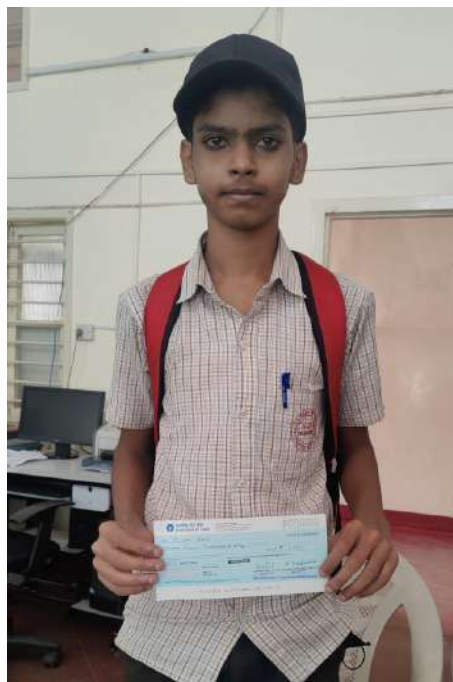
Vocational Training Support

KSCCW's Vocational Training Support has been initiated to cater to the needs of young boys and girls who have completed their 10th standard with a minimum mark of 50% and above.

The following are few of the courses opted by the beneficiaries:

- ★ ITI
- ★ Diploma in any stream like computer hardware, electrical repair and plumbing etc
- ★ Carpentry
- ★ TV, Mobile, Refrigerator, washing machine & other electrical appliance repair
- ★ Automobile course – 2-wheeler, 4-wheeler, etc.
- ★ Nursing

The project aims at helping young children from the economically weaker sections to undergo short term vocational training. This helps them to secure good jobs within a short period of time thereby making them economically independent. The duration of the courses depends on the course selected by the beneficiary, and he/she is provided financial support until the completion of the course. 7 students benefitted from the programme for the year 2022-2023.

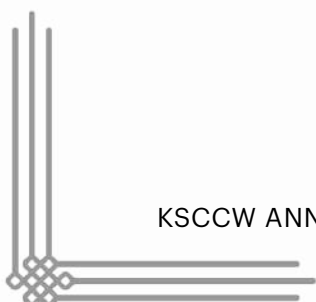
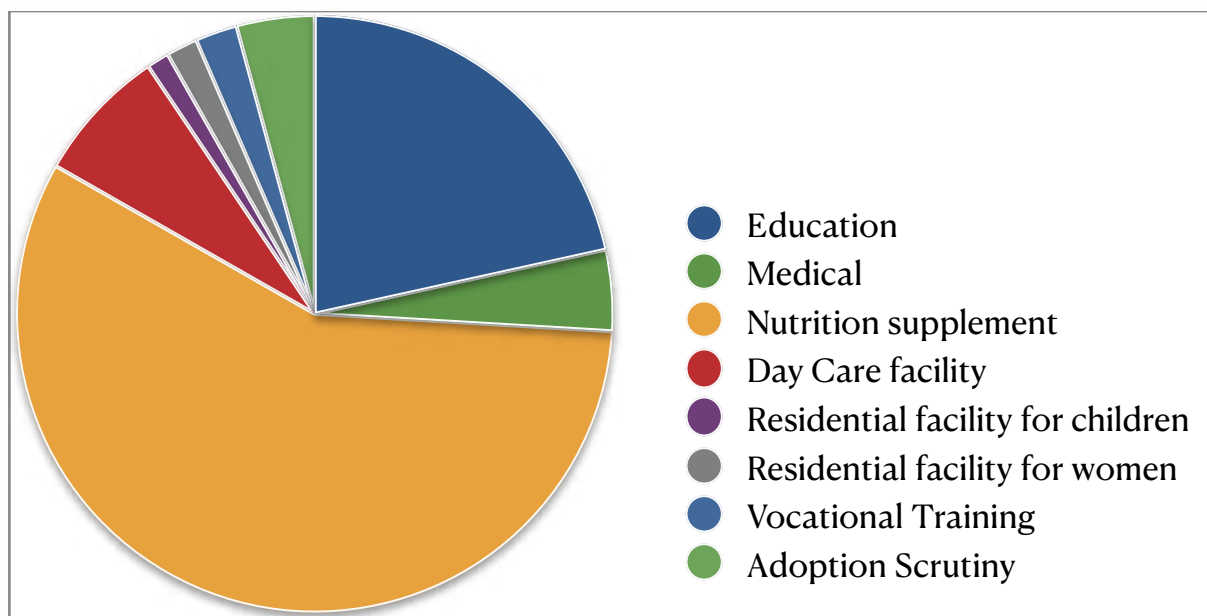
